School Description

Welcome to C.C. Carpenter Elementary School, the home of the Patriots where the 6 pillars of CHARACTER COUNTS! are continually practiced. We create a bridge between childhood and adolescence that supports the academic, social, and personal growth of upper-grade elementary students as they transition from primary school to middle school. In 2018-2019, Carpenter Elementary School was in a transitional phase. Our regular school program continued for our 5th grade students and will conclude at the end of the school year as they transition into middle school. During this same school year, Carpenter Elementary implemented the inaugural Global Language Academies of Downey program in Transitional Kindergarten and Kindergarten. This program consists of Dual Immersion in Spanish and the Primary Year Programme (PYP) International Baccalaureate (IB). Carpenter Elementary is a Candidate School for the PYP IB certification. The Carpenter School team of teachers and staff join parents and community members in a collaborative effort to promote student development from acquisition of basic academic skills to the application of those skills through rigorous standards-based instruction. Carpenter Elementary School's child-centered environment focuses on providing a positive, supportive climate that enables students to develop social interaction skills and foster personal responsibility and helps them become successful, contributing members of a global society.

School Facility Conditions and Planned Improvements (Most Recent Year)

Safety concerns are the number one priority of Maintenance and Operations. District maintenance supervisors are proactive and conduct inspections at school sites on a continual basis. The District administers a scheduled maintenance program to ensure a suitable learning environment. At the time this report was published, all restrooms on campus were in good working order. Daily reports of incidents that require repair at the school sites are processed through work orders. Emergency repairs are given the highest priority. The remaining incidents are handled on a first-come, first-served basis to ensure efficient service.

To determine the condition of our facilities, our district sent experts from our facilities team to perform an inspection using a survey called the Facilities Inspection Tool, which is issued by the Office of Public School Construction.

School Safety Plan

Safety of students and staff is the primary concern at our school. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Monthly fire drills and disaster drop drills are conducted on a regular basis throughout the school year. A storage bin contains food, water, and other supplies for use during a disaster.

Our school is a closed campus. All visitors are required to sign-in at the school's office. Before school, after school, and during lunch administrators and other campus supervisors monitor activity and ensure student safety.

A Comprehensive School Safety Plan, which is revised annually, was developed by the school staff to provide students and staff a means to ensure a safe and orderly learning environment. Components of the Comprehensive School Safety Plan include: child abuse reporting procedures, teacher notification of dangerous pupils procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, suspension and expulsion policies, dress code, and discipline policies. The school safety committee and district personnel evaluate the plan annually and update the plan as needed. The School Safety Plan was last revised in October.

PD is differentiated for teachers and teachers have a choice in the PD that they attend. Our teachers are trained in Cognitively Guided Instruction for math and Balanced Literacy for Language Arts. Topics for math include, but are not limited to math routines, number choice, designing a math lesson, counting collections, classroom discourse, fractions, number sense and more. ELA topics included but are not limited to shared reading, interactive read aloud, word work, guided reading, writing, and more.
