General Expectations PART 1

Doty Middle School agrees to implement the following requirements:

Doty Middle School will hold a flexible number of meetings at varying times, including child care:

- Invitations will be sent home in English and Spanish, with plenty of notice and automatic dialer calls.
- Trained volunteers will provide childcare.
- Spanish translation will be provided at parent functions.
- Parent surveys will be given to determine parent interest needs.
- Information about Title I programs will be provided to parents of participating children in a timely manner.
- A Fall meeting will be held.

Doty Middle School will provide parents of students a description and explanation of the curriculum being used, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet:

- Please contact your child's teacher or counselor if you need assistance with curriculum, grades, or any other concerns regarding your child's academics and progress.
