BRING THESE ITEMS TO BUY A "TICKET":

1. **Current DHS ID Card with barcode is required** (NO copies or photos of ID Card)
2. This signed contract by you & your parent/guardian (even if you are 18 years or older)
3. Photocopy of your guest's school I.D. card OR driver's license (if guest is not a DHS student)
4. Signed contract by your guest and their parent/guardian (if applicable)

Admission Policy to Enter Dance:

1. **PICTURE I.D. (including full name on it) IS REQUIRED TO GET INTO THE DANCE.**
2. **There are no "tickets" given.** Instead, names are recorded using school ID cards with signed contracts. Picture ID (including full name) is used for dance entrance. "Tickets" may NOT be given, sold, or exchanged, without the consent & knowledge of administration.
3. Each DHS student can pay for a maximum of two admissions: one for him/herself and one for a guest.
4. Guest is permitted into event only in the company of the Downey student sponsor and must leave when the sponsor leaves.
5. All Downey High rules of conduct apply to DHS students and guests.
6. Any "ticket" changes may only be done through the DHS Bookkeeper prior to the last day of ticket sales.
7. Parents and students should understand there are **NO REFUNDS.**
8. Downey High School Administration reserves the right to refuse permission to any person to attend any event sponsored by DHS.

Dance Rules:

1. All individuals attending the dance will be subject to search by the event security staff.
2. Students who are on suspension or expulsion are not allowed to attend a DHS dance/event.
3. Guests from another school must not have been removed or transferred for discipline reasons from Downey High School. Guests must be high school age or older.
4. **If a guest is 21 years of age or older, you must speak to the DHS Principal for possible approval.**
5. **No one leaving the dance will be readmitted. No admittance past 9:00 p.m.**
6. Any violation of school rules will result in discipline in accordance with school policy and possible removal from the dance.
7. **Administration reserves the right to deny participation to future events for students not picked up within 30 minutes after the conclusion of the event.**
