General Expectations PART 1

Stauffer Middle School agrees to implement the following requirements:

Stauffer Middle School will hold a flexible number of meetings at varying times, including child care:

- Invitations will be sent home in English and Spanish, with plenty of notice along with automatic dialer calls.
- Childcare will be provided by trained volunteers.
- Spanish translation will be provided at parent functions.
- Parent surveys will be given to determine parent interest needs.
- Stauffer Middle School will provide information about Title I programs to parents of participating children in a timely manner:
- A Fall meeting will be held.
- · Written notification will be sent home with all Title I students, explaining the program

Stauffer Middle School will provide to parents of students a description and explanation of the curriculum being used, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet:
