PART D - BIDDING CLARIFICATIONS/QUESTIONS

- 1. Question: Most other contractors, what they are doing in order to save time is that they don't cover the floors prior to painting the walls, that being said there will be overspray on the floors, contractors will then power wash the floors, power washing of the floors will create a problem with the State as they mandate that no chemicals can go in the storm drain. Other contractors will just get through with that by saying that those are dry fall paint which is not the case. My question is will this kind of procedure will be allowed to perform? Does the district requires that all areas needs to be protected prior to painting? Answer: Contractor shall protect all surfaces from overspray, drips, etc. using drop cloths or other protection.
- 2. Question: Questions about windows there were lots of French windows, a lot of them, and these French windows take a very long time to perform the painting work because they need to be masked/covered square by square, other contractors will use spray liquid plastic to save time again, this process is not advisable for the reason that it will cause the paint to start peeling quickly. My question is will the District allowed this kind of methods/step for the French windows? Answer: The Contractor is permitted to use Jasco Liquid Mask & Seal, or approved equal, as a liquid mask for windows.
- 3. Question: Questions for Windows, Trims, Doors other contractors again, to save time, what they are doing is for instance the doors, they will paint the face of the doors, and about half an inch of the

side of the doors, and they will not completely paint the whole side to save time. My question is, will the district allowed this?

Answer: No. Contractor shall completely paint each surface of door from edge to edge.

 - <u>Answer</u>: General note 1 is not intended to define the scope of painting. See all General Notes and Site Notes (if any) for complete scope of painting.
- 5. <u>Question</u>: Per General note 12, do we add the \$40,000 allowance to our total base bid? There is no line item for separate allowance. Please clarify.
 - Answer: Yes, the allowance should be included in the base bid for each site. Per Document 00 41 13 Bid Form and Proposal, "The Bidder's Base Bid shall include a forty thousand dollar (\$40,000.00) allowance per school site for unforeseen wood rot and fascia repair."
- 6. <u>Question</u>: Per general note 12, please provide a proper sheet metal detail to connect to damaged or rotted fascia boards. Please clarify.
 - Answer: See new sheet SK-6 for detail.
- 7. Question: Regarding the General Conditions 00-72-13-9 SECTION 5.1.1: Will there be a DSA inspector per TITLE 24? Will the Contractor be responsible for verifying DSA 152 has been uploaded and approved in the box? Also, is the contractor responsible for DSA form 156 at the commence and completion of the project? Please clarify.
 - Answer: This project does not require DSA inspection or documentation.
- 8. <u>Question</u>: Sheets SK-1 through SK-5, Requesting to have the District implement an allowance for all unforeseen abatement of loose and flaking paint.
 - <u>Answer</u>: No. Bids should be based on removal of all loose & flaking paint. Refer to the included hazardous materials reports/specifications to determine extent of abatement.
- 9. Question: Per sheets SK-1 through SK-5 note NO. 3, multiple sites have an exterior wrought iron property fence. Will this be painted? Please clarify.
 - Answer: No, do not paint fences. General Note 15 has been added to each plan sheet to clarify this.




