 "Despite continued shortages, teachers can look forward to some priority access soon. Gov. Gavin Newsom announced Friday that 10% of California's weekly allotment of COVID-19 vaccine doses will be set aside for educators starting next month. Based on current vaccine allocations from the federal government, that will result in about 75,000 doses of COVID-19 vaccine for school employees"

# After weather-related delivery delays, L.A. will resume vaccinations Tuesday

FEB. 22, 2021 8:19 AM PT

The city of Los Angeles will resume vaccination operations Tuesday, officials said, following several days of <u>postponements and delays</u> driven by inclement weather.

Several of the city's large-scale sites, including Hansen Dam Recreation Area, San Fernando Park, Lincoln Park, Pierce College, Crenshaw Christian Center and Dodger Stadium, were forced to close Friday and Saturday when shipments containing at <a href="least 63,000 doses">least 63,000 doses</a> of COVID-19 vaccines became mired by rain, ice and snow battering much of the country.

This draft is being provided to demonstrate to you what a potential schedule might look like. However, in order to determine a finalized Hybrid schedule, families' decisions need to be collected in order to determine the number of students that will be returning for in-person Hybrid instruction and who will remain in full Distance Learning. <a href="Our top priority is keeping our elementary students with their current teacher">Our top priority is keeping our elementary students with their current teacher</a> because we know how important this is to both our families and our staff. Knowing the number of students that will be returning to an in-person Hybrid Model is required to support our work in creating the best schedule possible.



- Any plans could be significantly revised by the final adopted language of the bill

## EDUCATION-BASED ATHLETICS COVID-19 MODIFICATIONS

- <u>CDPH Youth Sports Guidelines</u> (please review for complete Return to Play details)
- CIF Guidelines will be adjusted weekly
- In the event of a positive test for COVID-19, schools will follow the current CDPH Guidelines for Schools
- Any student-athlete testing positive for COVID-19 may not return to practice or competition until cleared by their physician
- Schools must still follow all guidelines from their local county and the governing board of their school district or private/parochial school

CIF Season 1 Sports (January - April): Traditional Competitive Cheer, Cross Country, Field Hockey, Football, Gymnastics, Skiing/Snowboarding, Girls Volleyball, Water Polo

CIF Season 2 Sports (March - June):
Badminton, Baseball, Basketball, Competitive Sport
Cheer, Golf, Lacrosse, Soccer, Softball, Swimming &
Diving, Tennis, Track & Field, Boys Volleyball, Wrestling

\*Please refer to respective CIF Sections for verification of seasons of sport

\*Outdoor Sports in Red (Substantial) and Orange (Moderate) Tiers may hold competitions, regardless of county tier status, if <u>respective county COVID-19</u> <u>adjusted case rate is equal to or less than 14 per</u> 100,000.

Additionally, the sports of <u>football</u> and <u>water polo</u> must conduct COVID-19 <u>testing once per week</u> in order to compete. Testing for these sports will be required until their county meets the red tier metrics. CDPH to provide further details regarding testing.

#### WIDESPREAD

Sports allowed in this tier: Cross Country, Golf, Skiing/ Snowboarding, Swimming & Diving, Tennis, and Track & Field.

#### SUBSTANTIAL

Sports allowed in this tier: \*Baseball, \*Field Hockey, \*Girls Lacrosse, and \*Softball.

#### February 16, 2021 County Tier Status



#### MODERATE

Sports allowed in this tier: Badminton, \*Football, Gymnastics, \*Boys Lacrosse, \*Soccer, and \*Water Polo.

#### MINIMAL

Sports allowed in this tier: Basketball, Competitive Cheerleading, Volleyball, and Wrestling.

# CIF Sports Update – Cont.

#### \*Play in Less Restrictive Tiers: Outdoor High-Contact Sports

Outdoor high-contact sports (orange tier) can be played in the purple or red tier with an adjusted case rate equal to or less than 14 per 100,000 under the following conditions:

## Implement and strictly adhere to the following additional general guidance:

- Informed Consent
- •Testing antigen or PCR (regular and postseason antigen or PCR testing of sports participants and coaches weekly. If competing, testing performed with test results made available within 24 hours of play)
- Outdoor high-contact sports
- Football
- Lacrosse (boys/men)
- Soccer
- Water polo
