CORRESPONDENCE RECEIVED No correspondence was received.

#44 ORAL COMMUNICATIONS Ms. Rademaker shared that she attended the recent Board of Education meeting on Tuesday, September 1st, via Zoom. She stated that she also participated in the School Board Candidates Information Meeting on Thursday, September 10th and she was grateful to all the administrators that presented on their respective departments.

Mr. Kennedy shared that he also attended the September 1st Board of Education meeting. He thanked the Board for nominating him to another 3-year term on the Personnel Commission, which he stated he would gladly accept.

Mr. Kennedy shared that Glenn Yamasaki recently received a phone call from a former student and his engineering firm was looking to hire some part-time students. Mr. Yamasaki gave him the names of three students who were subsequently hired by the firm. Mr. Kennedy wanted to share that our schools go beyond just educating our students, we also assist them in finding employment.

Ms. Lumsdaine shared that Downey High School was holding a drive on Friday, September 18, 2020, from 9:00 am to 3:00 pm, to collect cases of water which will be given to the first responders fighting the various wild fires in California.

Ms. Lumsdaine shared how much the District will miss Paul Deines, Personnel Analyst, who has accepted the position of Director at Fullerton School District. She wished him much luck and success.

Ms. Lumsdaine acknowledged the attendance of Donald LaPlante, President, Board of Education; Tod Corrin, Vice President, Board of Education; Giovanna Perez-Saab, Member, Board of Education; Dr. John Garcia, Superintendent; Alyda Mir, Assistant Superintendent, Certificated Human Resources; Lorraine Navarro, President, CSEA Unit I; Pam Martinez, Past President, CSEA Unit I; Wanda Iacovitti, Treasurer, CSEA Unit I; John Shook, Director, M.O.T.
