# **APPROVED MINUTES OF OCTOBER 25, 2021**

Alfredo Perez moved, Jorge Somoano seconded, and the motion carried unanimously to approve Official Minutes of the regular meeting of the Citizens' Bond Oversight Committee meeting held on October 25, 2021 as submitted or with the necessary corrections.

#### RECEIVE AND ACCEPT THE AUDIT REPORT

Rick Alonzo expressed that the district indeed spent funds approved by voters for projects. After reviewing a large amount of expenditures, Eide Baily, LLP, Certified Public Accountants agreed with District number and had no findings. Jorge Somoano questioned why the local revenues were negative and whether the encumbrances were liquidated. Rick Alonzo and Christina Aragon communicated that the county pool was negative creating an unrealized lost and defined encumbrance as services not yet received or included in the financial statement. Jeff Townsend inquired if the fund balance included commitments and Rick Alonzo responded no.

Jorge Somoano moved, Danielle De Buhr seconded, and the motion carried unanimously to accept the Audit Report on the Building Fund (Measure O) for the 2020-21 fiscal year as prepared by Eide Bailly, LLP, Certified Public Accountants.

### **REVIEW ANNUAL REPORT**

Christina Aragon introduced the new Annual Report format to be approved at the next committee meeting. Danielle De Buhr suggested to add a photo of the Sussman two-story building or gymnasium, and Jorge Somoano asked for the expenditures to reconcile with the audit report.

# **REVIEW PROGRESS OF SCHOOL CONSTRUCTION PROJECTS**

Doty Middle School gymnasium is currently occupied. Due to the pandemic causing long lead times, the north field is left to be completed. The entire site will be irrigated by reclaimed water as the district has found this to be more cost effective. This summer the culinary arts project and lunch shelters will begin.

Stauffer Middle School gymnasium construction is underway and will be open the start of next school year. Bernards Construction was awarded the preliminary Guaranteed Maximum Price (GMP) for Stauffer two-story building including fifteen classrooms will begin in June. Jeff Townsend inquired if the culinary arts room will be similar to that at Griffiths. Vince confirmed and answered no to Jorge Somoano's question regarding whether the district has received funding from the water district.

Jorge Somoano requested a list of past, present, and future projects to be presented during the construction updates.
