Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. Percentage of Students Meeting or Exceeding the State Standard on CAASPP

Monthly fire drills, disaster drop drills, and lock-down/lock-out drills are conducted on a regular basis throughout the school year. A storage bin contains food, water, and other supplies for use during a disaster.

Our school is a closed campus. All visitors are required to sign-in at the school's office. Before school, after school, and during lunch administrators and other campus supervisors monitor activity and ensure student safety.

A Comprehensive School Safety Plan, which is revised annually, was developed by the school staff to provide students and staff a means to ensure a safe and orderly learning environment. Components of the Comprehensive School Safety Plan include: child abuse reporting procedures, teacher notification of dangerous procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, suspension and expulsion policies, dress code, and discipline policies. The school safety committee and district personnel evaluate the plan annually and update the plan as needed. The Comprehensive School Safety Plan was last revised in December 2022.

In addition to everyone's physical safety, Alameda is also ensuring the social and emotional well-being of our students, families and staff. Alameda and our District have resources to address various health, social, emotional and mental health needs. At Alameda, we know that bullying can be a major problem and impedes learning. We actively mitigate this problem by being Brave Bystanders. When we encounter bullying, WE SPEAK UP, REACH OUT AND GET HELP. Our School Psychologist and School Clinical Therapist work with our older students learning to navigate peer pressure and social media in a positive way.

To make Alameda the best place to learn we live by our motto: We are Kind, Safe, Respectful and Ready to Learn.
