#74 ORAL COMMUNICATIONS Ms. Rademaker shared that she attended the Board meeting and announced the approval of her reelection to serve another term as the Union appointee. She expressed her appreciation to both union presidents and their executive boards.

We have received a request from Heather Princiotta, Program Administrator, to establish a new position with duties corresponding to the current classification of Senior Instructional Assistant - Sign Language. This new position is being created for classroom support on the campus of DHH Program/Gauldin Elementary School.

SUBJECT: SALARY REALIGNMENT – BUS DRIVER

ACTION ITEM

A recent comparability and pay study was conducted to review the compensation of the Bus Driver classification. The study determined that the position is underpaid by approximately 40% compared to the median of comparable organizations.

Adjusting the Bus Driver salary schedule will bring compensation more in line with the market standards, assisting the District with recruitment and retention efforts for this critical classification.

The District and the California School Employee Association (CSEA) Chapter 476 have signed a Memorandum of Understanding (MOU) to implement the salary realignment. The Board of Education approved the revised salary schedule and MOU on October 14, 2025.
