General Expectations PART 1

Rio Hondo agrees to implement the following requirements:

Rio Hondo will hold a flexible number of meetings at varying times, including child care:

- Invitations will be sent home in English and Spanish, with plenty of notice along with automatic dialer calls.
- Childcare will be provided by trained volunteers.
- Spanish translation will be provided at parent functions.
- Parent surveys will be given to determine parent interest needs.
- The school will provide information about Title I programs to parents of participating children in a timely manner.
- A Fall meeting will be held.

Rio Hondo School will provide to parents of students a description and explanation of the curriculum being used, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet:

- Please contact your child's teacher or counselor if you need assistance with curriculum, grades or any other concerns regarding your child's academics and progress.
- This will also be discussed at the Title I Informational Meeting.
